**Consult Service**, an Italian consulting firm based in the city of Mantua, has been acquired by **White Lab**, an Italian vertical testing platform owned by the fund **White Bridge Investments**, the Italian website *Legal Community* reported.

The report, without citing any sources, said that the bidder has been served by Dentons, Giovannelli e Associati and Athena Associati.

Consult Service posted EUR 2.4m revenues in 2023, according to the business information provider *Cerved*.
